TMRA 2010 STATE RALLY

**LIMITED SPACES:** This year the TMRA State Rally will be held in Snyder, Texas. Due to the limited space for vendors we are limiting the number of types and categories of vendors this year. This will give vendors a greater opportunity to sell their products, good and services without having to compete with other vendors.

**VENDOR AREAS:** Placement is on a first come, first serve basis.

**VENDOR CAMPING:** RVs will not be allowed in the vendor area. There will be designated RV parking for all RVs. There will be no tent camping in the vendor area.

**CHECK-IN:** Check-in and setup will begin 3:00PM, Thursday, April 9, 2010 and will end Friday, April 10, 2010 at 9:00PM. No vendor will be allowed entry after that time there will be no entry or setup on Saturday.

**FEE & PAYMENT:** Vendor Fee for this event is \$75 for a 10 x 10; \$100 for a 10 x 20. Each additional 10 x 10 space required will cost an additional \$25. Vendors may apply 50% of the fee at the time an application is submitted, however, the remaining fee balance will need to be submitted and received **prior** to the deadline.

**DEADLINE TO MAKE APPLICATION IS MARCH 26, 2010.** Any vendor not remitting payment in full by this date will not be allowed in the event and any down-payment will be forfeited.

**SILENT AUCTION:** Texas Motorcycle Roadriders Association will again run an Auction. All proceeds from the Auction will be presented to a local charity. All vendors are required to donate at least one item to the Auction. This item will be picked up on-site at the Rally. TMRA will provide a receipt for the donation at the vendor's request.
